Meeting called to order at 7:02 p.m.

Roll Call: Niepoth, Murray, Valuet, Hagood and Alger.

Motion by Valuet, supported by Murray, to approve agenda, as presented, carried.

Motion by Murray, supported by Alger, to approve the October 4, 2021 Township Board Meeting minutes, as presented, carried.

Motion by Murray, supported by Hagood, to approve payment of the bills, and monthly bank service charges, totaling \$23,015.98, carried.

Valuet explained notations on certain Profit and Loss Statement and Balance Sheet line items.

Snowplowing quote received from Giar Excavating: half lot plowing at \$46.00 and full lot at \$78.00. Motion by Murray, supported by Hagood, to approve Giar Excavating quote for snowplowing, carried.
