Meeting called to order at 7:00 p.m.

Roll Call: Niepoth, Murray, Valuet, Hagood and Alger.

Conflict of Interest: None.

Motion by Valuet, supported by Murray, to approve agenda, with deletion of item 9A. Agreement with County for interment of unclaimed cremains and addition of 10D. Hall Lease Agreement, carried.

Motion by Murray, supported by Alger, to approve the April 3, 2023 Township Board Meeting Minutes, as amended, carried.

Motion by Murray, supported by Valuet, to approve payment of the bills, as presented, in the amount of \$34,086.13, carried.

Old Business:

Valuet distributed a copy of the filed ARPA annual report and advised that the ARPA funds, currently in a separate account, should be moved to the General Fund so funds can be used and a final report can be prepared next year. Discussed proposals for redraft of Zoning Ordinance and Imaging of Brydon and Eldred cemeteries. Motion by Valuet, supported by Murray, to approve Northeast Michigan Council of Governments proposal to redraft the Township Zoning Ordinance, carried. Alger to follow-up on questions relating to Cemetery Imaging.

April 17th Planning Commission meeting discussed.

Hagood provided information on an exterior parcel drop box for UPS and other deliveries. Discussed need for proper signage on box. Motion by Niepoth, supported by Hagood, to purchase Barska Delivery Parcel Mail Drop Box, carried.

Supervisor mentioned Michigan Spark Grant availability.

Proposed revised Hall Lease Agreement presented incorporating advice from Township attorney. Hagood did not agree with proposed changes as presented and will revise draft for future review by Board.

County Commissioner VanAlstine updated the Board on county business.
